

**2018 INGHAM COUNTY FAIRGROUNDS
HORSE SHOW RENTAL FEES**

THE FOLLOWING FEES ARE FOR A 2 OR 3 DAY SHOW
FEES FOR 4 OR MORE DAY SHOWS WILL BE AN ADDITIONAL \$1,500 PER DAY

Facility Fee

\$300 per show for organizations that hold 1-3 shows per year
\$100 per show for organizations that hold >4 shows per year

North End with Main Arena Building - \$4,500 minimum per 2 or 3 day show

Includes:

Dickinson and North Commercial Barns
Use of PA system
2 Water dumps and janitorial supplies
After 2 water dump/drags the cost will be \$60 each

Extra Barn Fees:

\$300.00 – Commercial South, Barn A or Barn B
\$250.00 – All Other North End Barns

South End with Outside Arena - \$2,750 minimum per 2 or 3 day show

Includes:

ZZ Barn
Use of PA system
2 Water dumps and janitorial supplies
After 2 water dump/drags the cost will be \$60 each

Extra Barn fees:

\$300.00 – UU or VV Barns
\$250.00 – All Other South End Barns

Covered Practice Arena

\$500.00 per show
\$60.00 per dump for watering arena and drag

Infield Arena: \$450 per day

Show will pay \$60.00 per dump for watering arena.

Entire Grounds: \$6,750 minimum per 2 or 3 day show.

Dickinson and North Commercial Barns, ZZ Barn
Use of PA system
2 Water dumps and janitorial supplies
After 2 water dump/drags the cost will be \$60 each

Extra Barn Fees:

\$300.00 – Commercial South, Barn A or Barn B, VV or UU
\$250.00 – All Other Barns

Please note:

ALL BEDDING MATERIAL FOR ALL SHOWS MUST BE A WOOD BY-PRODUCT

Other rental fees:

Brick Building: \$ 250.00 per day

OTHER FEES:

Concessions and Blacksmiths - \$75.00 for the 2 or 3 day show, \$25 per day for the fourth day and beyond.

Commercial - \$25.00 per event

Trash Pass Through Fee – Shows using the grounds for more than 3 days may be assessed an additional trash pass through fee.

Camping: \$20.00 per day. **Absolutely NO Horses allowed in the campgrounds. All horses MUST be stalled.**

Fairgrounds Personnel and a show representative will count campers each morning and report counts to show. **Both must sign count sheet.** Camping permitted in designated areas *only*.

Wednesday 5:00 PM will be the earliest arrival for a 3 or more day show.

Early arrival camping will be with permission only, and only in gravel camping areas.

“SHOW IS RESPONSIBLE FOR COLLECTING ALL CAMPING FEES”

General Information:

- Any layover between shows will be charged:
\$20.00 per horse per day
\$20.00 per day for camping in designated areas only.
This is the shows' responsibility to collect.
- **Dogs must be on leashes and under owners control at all times. Ingham county animal control will be patrolling the facility. Unleashed dogs will be picked up.**
- Do not take stalls apart. We will inspect **during the show and immediately after.** If any stalls are dismantled, the show will be charged **\$150.00 per stall** for resetting.
- **Tampering with electrical equipment or unauthorized connections will result in a \$500.00 fine per occurrence. This is the show's (LESSEES') responsibility. Violators will be asked to leave.**

- Lessee is responsible for rented facilities from their arrival until Monday morning at 8:00 a.m. That responsibility includes turning off all lights at night, and upon departure. Also making sure no water is running (toilets, sinks, outside faucets) at night, and upon departure.
- Fairgrounds personnel will be on the grounds from 7:00 a.m. until 4:00 p.m. daily. Other than emergencies, the Lessee is charged for extra time required. The call back fee is \$100.00. Call back charge is for a minimum of 2 hours and will be required for all *routine* services including tractor and drag and water dumps. If staff is required to stay beyond 2 hours, the charge will be \$50 per hour.
- It shall be the responsibility of the Lessee for proper placement of sharps disposal containers, and proper disposal of all sharps.
